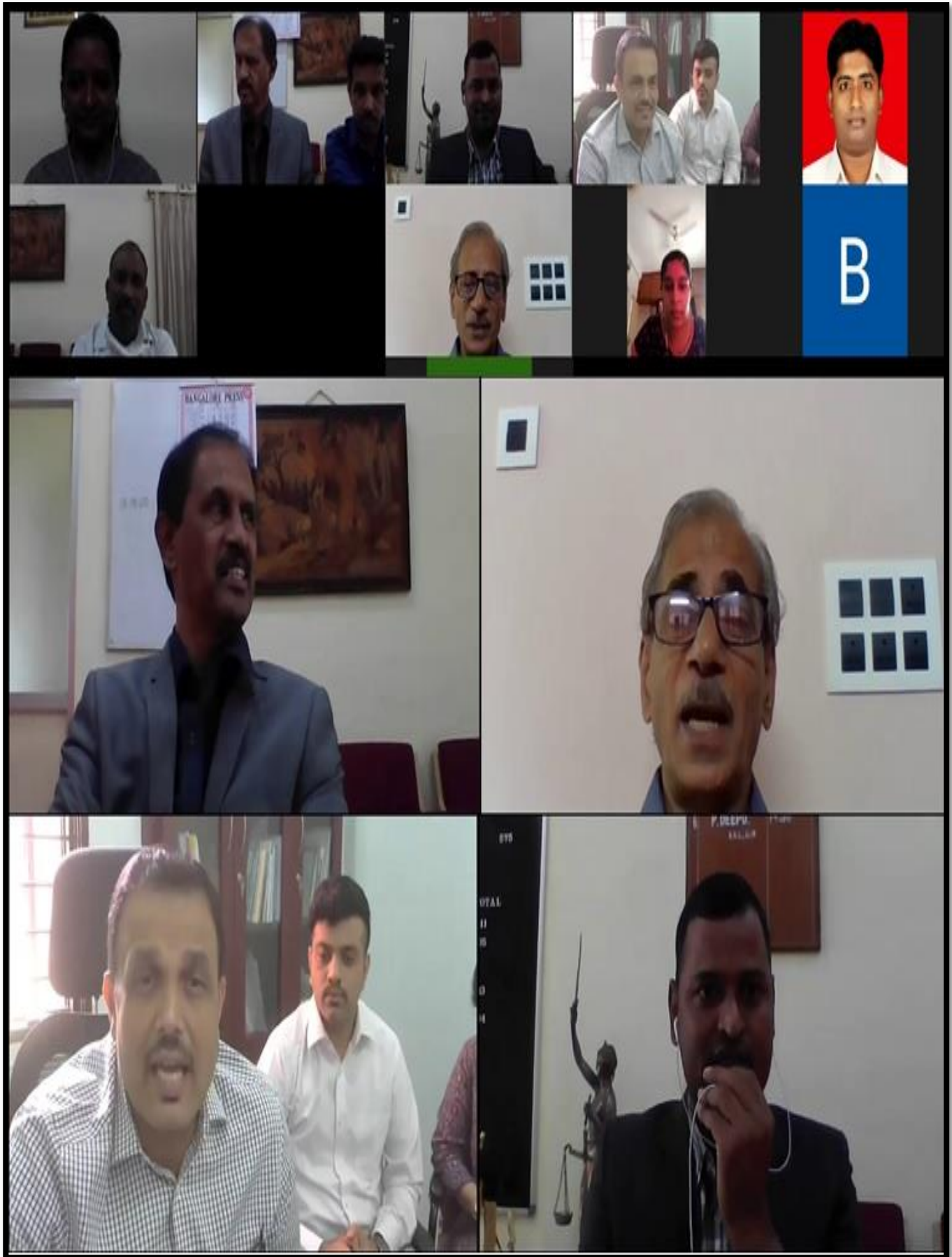
*Organized Webinar*

### Power of Entry, Search, Seizure and Arrest u/s 50 WLA 1972

- Production for inspection any animal or trophy, license or permit
- To Stop and search vessel or vehicle and check baggage or other things in possession
- Seize any animal, plant or derivative or any tool, vehicle or vessel used for commission of an offence
  - Informator to Chief Wildlife Warden and submit before the Magistrate
  - Disposal of Animal Trophy by Asst. Dir. of Wildlife Preservation or CWV or Any authorized person
