**III Semester**

**Course-I: JURISPRUDENCE**

- This course in Jurisprudence is designed, primarily, to induct students into a realm of questions concerning nature of law. Therefore, the first part of the course is concerned with important questions like, what is law, what are the purposes of law?, the relationship between law and justice and the like.
- The second part gives information about the important sources of law. The emphasis is on important issues concerning law with reference to ancient and modern Indian Legal Thought.

**Course-II: LABOUR LAW-II**

- This course gives proper information about Bonded Labour System, Prevention of Sexual Harassment against women at working place and Equal Remuneration Act.
- This course helps to the student to abolition of child Labour and protection of contract Labour and how to get the Maternity benefit act.
- This course helps the student to understand the problems of Labour and how lawyer could give justice for Labour in case if they faced the problems in industry.

**Course-III- LAW OF TAXATION**

- A student of taxation will have to make a detailed study of tax policy and tax in India.
- The direct taxation is a powerful incentive or disincentive to economic growth, a lever which can rise or depress savings and capital formation, and instrument of reducing income disparities.
- This course gives complete information to students about ITR, Indian Income Act and procedure to recovery of tax from the defaulter.

**Course-IV: CRIMINAL PROCEDURE CODE**

- The course is aimed at driving home the students how the pre-trial, trial and the subsequent process are geared up to make the administration of criminal justice effective.
- The course will acquaint the student with organisation of the functionaries under the Code, their power and functions at various stages and the procedure according to which these powers and functions are to be exercised.
- The students will also undertake the study of two cognate Acts as a part of this course viz.: Juvenile Justice Act and Probation of Offenders Act.

**Course-V: ADMINISTRATIVE LAW**

- For students this course will deal with the nature, scope and functions of Administrative Law, the nature and control of delegated legislative power, regulation of discretionary powers and general principles of administrative adjudication.
- Further this course deal with the role played by courts in the development of Administrative Law and the Focus is on their role in protecting the rights of individuals against abuse of administration.
- In addition, adjudicatory powers of the administration and liability of administrative authorities are also studied in this course.

### **COURSE-III: OPTIONAL-II: BANKING LAW**

### **COURSE-III: OPTIONAL-II: INSURANCE LAW**

- This course is designed to acquaint the students with the conceptual and operational parameters, of insurance law.
- The insurance idea is an old institution of transactional trade. Even from olden days merchants who made great adventures gave money by way of consideration, to other persons who made assurance, against loss of their goods, merchandise ships and things adventured.
- The insurance policy, being a contract, is subject to all the judicial interpretative techniques of rules of interpretation as propounded by the judiciary. Besides, the insurance idea has a compensatory justice component.

### **COURSE-V: CLINICAL COURSE-I: PROFESSIONAL ETHICS AND PROFESSIONAL ACCOUNTING SYSTEM**

- The course is designed to imbue students with these high values forming the basis of the profession so that they can live up to those standards in their professional life.

- Intellectual Property is one of the fastest growing subjects all over the globe because of its significance and importance in the present era. Disseminate information on national and international IPR issues.
- Intellectual Property Law has assumed a great importance in recent times as a result of the recognition that "knowledge is property". The creations of the human brain as IP are required to be understood and protected.

**COURSE-II OPTIONAL-III: PENOLOGY & VICTIMOLOGY**

- This course offers a specialist understanding of criminal policies including theories of punishment, their supposed philosophical and sociological justifications and the problem of exercise of discretion in sentencing.
- In addition, the course introduces students to the discipline of victimology which will shift the study from accused centric approach to much needed victim centric approach.
- This course helps the students to focus on how crimes are defined and punished as well as how prisons are managed.

**COURSE-III: OPTIONAL-IV: INTERPRETATION OF STATUTES & PRINCIPLES OF LEGISLATION**

- This course equips the students regarding who will interpret, in what circumstances interpret and what are the matters to be considered for interpretation of statutes.

- It gives clarity about Karnataka Land revenue Act, Land Reforms Act and Karnataka Land Ceiling Act
