On 18<sup>th</sup> November 2020, the IQAC wing and Student Council of our college had organized webinar on “Justice V. R Krishna Iyer: An Activist Judge”-to mark 105th Birth Anniversary of Justice V. R Krishna Iyer. The distinguished speaker of the webinar was Dr. **Chidananda Reddy. S. Patil.**, Professor of Law, Karnataka State Law University, Navanagar, Hubballi. Prof. K.B. Vasudeva, Legal Director, briefed the objectives and relevance of topic of the webinar. Principal, Smt Deepu. P, welcomed all participants and introduced the speaker



**Prof. Chidananda Reddy. S. Patil.**, while addressing the participants, expressed the concern on the relevance of the topic. He enlightened all the participants by expressing that, Justice V. R. Krishna Iyer, an Activist Judge, born on November 15<sup>th</sup>, 1914 in Vaidyanathapura near Palakkad, Kerala and they started legal carrier in 1937 under his father, a leading criminal lawyer V.V. Rama Iyer and Krishna Iyer has also tried his luck in politics and elected as an MLA to Madras Assembly and also appointed as minister in the government and subsequently his passion to law brought him to legal profession and he was elevated as judge of Kerala High Court in 1968 and he resigned and join Law Commission of India and later elevated as judge to Supreme Court of India in 1973.

Further he said that V.R. Krishna Iyer had delivered more than 400 landmark judgments. He was a person of ability and caliber with innovative thinking and analytical mind, person on a mission for cause of social justice, human rights jurisprudence and awarded with “Padma Vibhushan”. All his judgments are filled with valuable ideas. He was the shining star in the galaxy of judges. Professor also advised the participants to read books like- Autobiography of Fali. S. Nariman, God Save the Hon’ble Supreme Court Indian Legal System: Can it be Saved, State of the Nation, Arbitration Series; V.R. Krishna Iyer ‘Unspeakable Anecdotes’. He cited that all these books have references to Justice. V.R. Krishna Iyer.

Professor also expressed that, Justice. V.R. Krishna Iyer was a path finder and creative judicial thinker and is known for his contribution towards rendering social justice. Once Justice M. N. Venkatachalaiah said that the range of Krishna Iyer mind equates to Aristotle. H. M. Seervoi, a noted Constitutional Law author wrote, the Supreme Court move towards its finest hour after Justice. V. R. Krishna Iyer rejected Smt. Gandhi application for an unconditional stay that changed the history of nation. He concluded his speech with the words of Fali Nariman that, ‘when Justice Krishna Iyer speaks the nation listens’ and that was the significance of Justice V. R. Krishna Iyer. Finally he clarified all question and doubts posed by the participants. The Coordinator of the webinar, Dr. Kumara.N.J rendered vote of thanks.

The special lecture was organized on the occasion of celebrating World Social Justice Day on 19-02-2022 at Room No 9. Dr. Maruthi. T.R, Prof of Law, Department of Studies in Law, University of Mysuru, were invited as a resource person to speak on World social Justice Day. Principal, Dr. P. Deepu welcomes all and introduced the resource person to students.

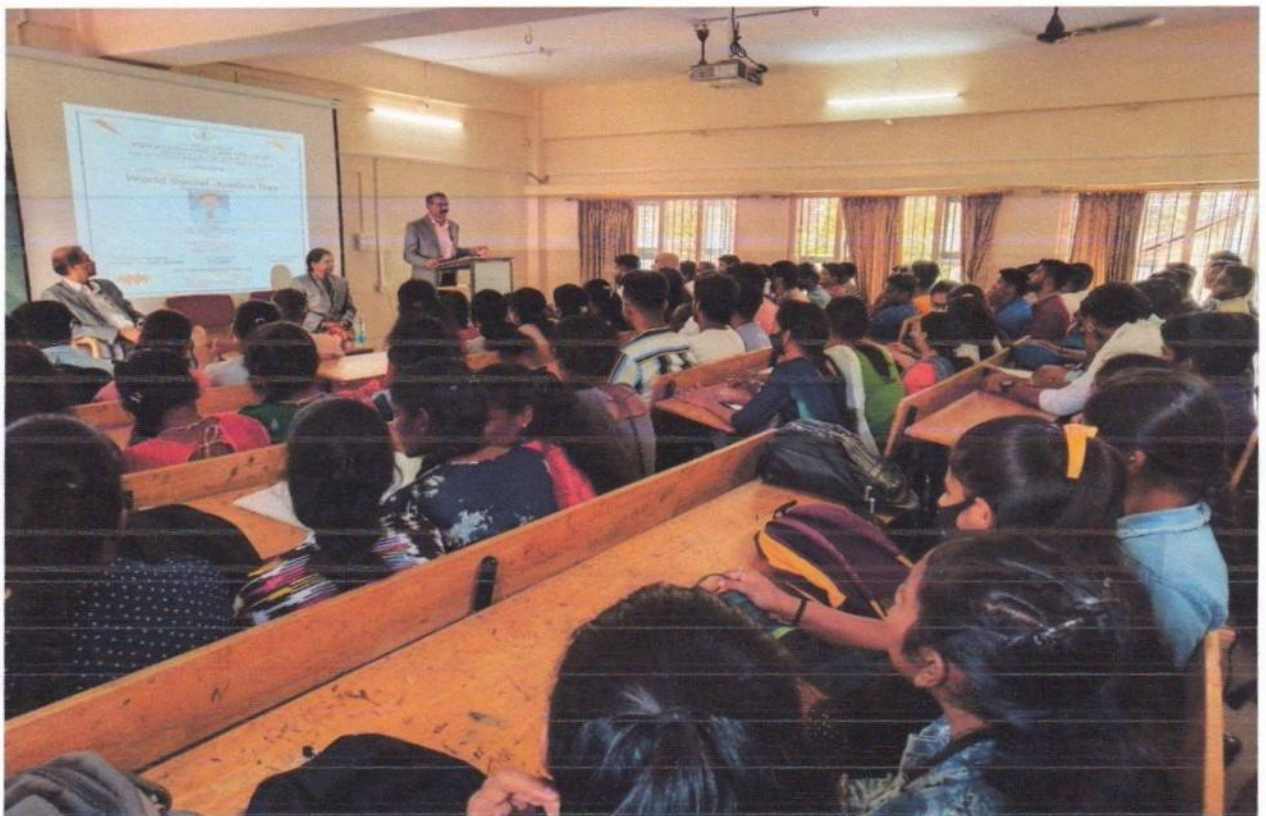
Prof. Maruthi. T. R while addressing students expressed significance views on world social justice day. In opening words they said, there is huge injustice in all societies due to poverty. To achieve social justice, there shall be proper implementation of law and while interpreting law our legal fraternities should have knowledge of social justice. If we can't eradicate poverty across the world purpose of social justice cannot be served. Further, they appreciated works of international scholars like Jeremy Bentham, Henry Savigny and other international instrumentalities which have engaging in providing justice to all classes of society. They stated that, justice is refined oil which must be extracted from crude oil like law and added importance of organic theory of rights which emerged on the basis of cultural variables. Further, they expressed their views on impact of WTO on Indian agriculture and correlates with other sectors.

They further enlightens students on theories of Buddha, Basavanna, Swami Vivekananda and Dr. B. R. Ambedkar's as they are profounder and promoters of social justice to vulnerable classes at the world. State has to understand the objectives of the social justice, if not very purpose of the justice will be undermined and the unscientific religious illusion is also barrier to achieve social justice. They further said, while distributing justice our judicial system should concentrate on values of preamble, fundamental rights, DPSP and other ideals of our Constitution. The concept of social justice articulated in the constitution itself and also embedded in the constitutional values. The purpose of social justice is to achieve humanity and as mentioned in preamble of constitution social justice can be achieved through, social, economic and political aspect. They further explored lack of scientific approach in the mindset of society which is hindering the development of all society. They also stressed the significant contribution and sanctity of justice by Supreme Court through its various judgments since Sajjan singh case to Rajnarayan and other relevant cases.

In their concluding speech they mentioned the Buddha, Basavanna, Swami Vevekananda and Dr. B.R. Ambedkar's ideas, ideal efforts on social justice and expressed Dr. B.R Ambedkars quote that, where there is injustice, the future generation will not grow and suffer injustice, thus interpretation of justice is required to achieve the object of social justice. Prof. K.B. Vasueva, Director of legal studies were also presided and briefly expressed their views on social justice. Sri. H.S. Shivakumara, Assistant Prof of Law rendered vote of thanks. Dr. Kumara. N.J, Dr. Sridevikrishna, Dr. Prakruthi. A.R and More than 150 students were attended. The special lecture was intellectual, though provoking and fruitful to students.
