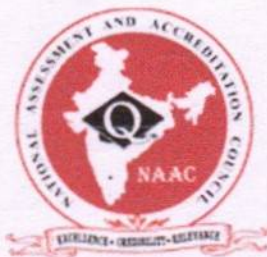

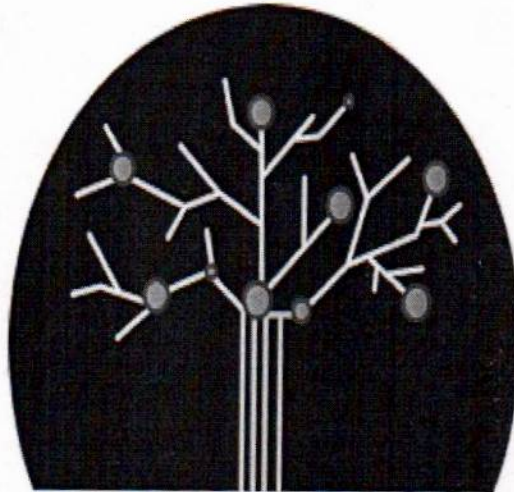



RULES AND BYE-LAWS

- 1. NAME OF THE ASSOCIATION:** The name of the Association shall be "Vidyavardhaka Law College alumni Association, Mysuru hereinafter called VVLCAA.
- 2. REGISTERED OFFICE:** The Registered office of the Association is Vidyavardhaka Law College, at Sheshadri Iyer Road, Mandi Mohalla, Mysuru -570001.
- 3. AREA OF OPERATION:** The Members of VVLCAA may be from in any part of India and abroad having graduated from Vidyavardhaka Law College, Mysuru, hereinafter called VVLCAA. The VVLCAA shall have power to receive books and endowments in the form of gift by Alumni/ Alumna .if any, acceptable to VVLCAA and not inconsistent with its objectives.

The Executive committee has full power to reject the applications of an Alumni opting for membership without giving any reason.

The executive committee and any other member have no jurisdiction or power to interfere with the administration of the college and the Vidyavardhaka Education Institution Management.

4. MEMBERSHIP: The Membership of the Association shall consist of two categories of members,

- a) The students who have studied the law course early to the year 2018 if he/she intend to become the member of the association i.e., VVLCAA Mysuru he /she submit the application in the prescribed form along with membership fee.
- b) The students who have joined the law course subsequent to year 2018 they will become member of the association i.e., VVLCAA Mysuru for life automatically.

5. CANCELLATION OF MEMBERSHIP: The membership in the VVLCAA may be cancelled under the following events:

- a. When a member resign voluntarily;
- b. When a member dies;
- c. When a member is removed in accordance with the Bye-laws of the society.

6. ASSETS OF VVLCAA: Assets of VVLCAA could be in the form of gifts from donors, subsidy from the government, grant from statutory bodies and like. Distribution of assets of VVLCAA in any manner among the members or others is strictly prohibited and it should be utilized for the welfare of the Association only.

7. EXECUTIVE COMMITTEE MEETING: The meetings of the Executive Committee shall consist of two types: (a) Ordinary Meetings; and (b) Special Meetings.

- a. **Ordinary Meetings:** The Executive Committee shall compulsorily meet once in three months every year to review the achievements/progress of the previous meeting and stipulate the activities for the coming month.
 - b. **Special Meeting:** The president of the Executive committee at any time at the request of one-third of the members of the Board of Management or one-tenth of the ordinary members who are eligible to vote convene a meeting in accordance with the provisions of the Karnataka Registration of Societies Act, 1960. The date, time, venue along with the agenda of the meeting shall be communicated to the members.
- 8. QUORUM:** The quorum of the general body meeting or special general body, meeting shall have minimum 10 per cent of the members. Any amendments of memorandum of association and rules and bye-laws resolution to be passed shall be assented by two-thirds of such members present in these meetings 2/3 majority of the members present shall effect amendments to its memorandum of association shall effect amendments to its memorandum of association and rules and bye-laws of VVLCAA at any time subject to the provisions of section 9 of Karnataka Societies Registration Act, 1960 subject to the condition that no amendments to the memorandum of association and rules and bye-laws shall be made which may prove to be repugnant to the provisions of Income Tax Act, 1961 and/or contrary to the overall objects of VVLCAA.
- 9. ELECTIONS:** Elections to the Executive committee shall be held once in five years by secret ballot.
- 10. CONSTITUTION OF THE EXECUTIVE COMMITTEE:** The Executive Committee shall consist of 11 members from amongst the members of VVLCAA and it shall consist of one President, one Vice President, one Secretary, one Treasurer and 10 Executive members.

11. POWERS AND DUTIES OF THE EXECUTIVE COMMITTEE: The powers and duties of the Executive committee shall comprise of:

- c. Admission of members to the society;
- d. Removal of members from the society;
- e. Convening of quarterly, annual and special meeting; and
- f. Any other responsibility entrusted to it.

12. POWER AND DUTIES OF OFFICE BEARERS: The power and duties of the members of the Executive committee shall be as follows:

- a. **The President:** The president shall preside over all the meetings of EC and GB. In the absence of President the Vice President shall preside over all meeting of EC and GB
- b. **Secretary:** The secretary shall work for the VVLCAA in all its activities, like making new members sending meeting notices/circulars to members and other constructive activities of VVLCAA.
- c. **Treasurer:** The treasurer shall prepare budgets, keep accounts, keep records, maintain custody of assets collection of membership fees, submit proposals of new membership(s), assist the Secretary in meetings and remit the amounts collected to Bank etc. All transactions shall be done by cheques only. All vouchers shall be got signed by Secretary of VVLCAA. In the absence of President, the Treasurer shall preside over the meetings.
- d. **Members of the Executive Committee:** The Members of the Executive Committee shall assist the VVLCAA in all its constructive activities.

13. ANNUAL GENERAL BODY MEETING: The General Body of VVFGCAA shall hold its meetings and transact business as per provisions of societies Registration Act, 1960. It may transact any other business not inconsistent with the rules and byelaws and VVLCAA.

The Annual General Body (AGM) meeting shall be held every year as per the regulations of the societies Registration Act, 1960. Duly audited annual accounts shall be placed in the annual general body meeting every year. The notice for holding annual general body meeting shall be sent twenty-one days before the date of AGM being held. Agenda circulated along with the meeting of the notice shall include the invitation to send propositions and resolutions, which shall be sent ten days before the date fixed for AGM.

Agenda may include the information relating to calling for nomination in respect of the year when elections are due. In such AGM, elections shall be held by secret ballot. The president of VVLCAA may nominate Returning Officer, who shall take charge of conducting such elections. There shall be a register containing the details of members such as name, address, age, profession etc. There shall also be registers containing details such as meeting proceedings and accounts.

14. OPEING OF BANK ACCOUNT AND ITS OPERATION: The funds of the association shall be deposited in the any scheduled bank as may be decided upon by the executive committee. The secretary of the society shall open a bank account in the name of association and the bank account shall be operated by joint signatures of the secretary and treasurer.

15. COMPLIANCE WITH LAW: In the event of dissolution or winding up of the society, the asset remaining as on the date of dissolution shall under no circumstances be distributed among members, but the same shall be transferred to another charitable society whose objectives are similar to those of this society and which enjoys recognition U/s 80G of the Income Tax Act 1961 as amended from time to time.

Section 21, 22 and 23 of the Karnataka Societies Registration Act, 1960 or in the event of VVLCAA cease to function or otherwise fails to carry out its stated objective, all the assets of the VVLCAA shall be transferred to VidyaVardhaka Educational Institution, Sheshadri Iyer Road, Mysuru.

16. WELFARE WITH LAW : The VVLCAA shall work with the following objectives:

- a. The service of the society is open to all irrespective of caste, colour, creed or religion.
- b. The VVLCAA members shall work for the benefit, good name and glory of the sacred institution represented by VVLCAA

17. AMENDMENT CLAUSE: No amendments to the society deed memorandum of Association/Bye-laws Rules and Regulations shall be made which may prove to be repugnant to the provisions of sec.2(15).11,12 and 12A & 80G of the II Act, 1961 as amended from time to time. Further NO AMENDMENT SHALL BE CARRIED OUT WITHOUT PRIOR APPROVAL OF THE COMMISSIONER OF INCOME TAX. If the original of the Trust Deed is a registered document, the amendment deed of codicil invariably must be a registered document only.

18. ACCOUNTS CLAUSE: All accounts of the Association shall be maintained regularly, the account shall be duly audited by a Chartered Accountant. Every year, the accounts shall be closed by 31st March.

19. FUNDS: The funds of the VVLCAA and its utilization shall be specified under the provisions of Sec. 13(1)(d) read with Sec.11(5) of the I.T. Act, 1961 as amended from time to time.

- a. The property, funds of the VVLCAA shall be utilized solely towards the promotion of the objectives of the Association as set forth in the bye-laws of the VVLCAA and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonds or otherwise beneficially howsoever to the members of the society provided that nothing therein contained shall prevent the payment in good faith of remuneration to any officer or employee of the association or to any member of the Alumni Association or other person for any services actually endured.
- b. The objective and activities of the association are non-profit a public charitable in nature.

20. We abide by the Rules and Regulation under Karnataka Societies Regulation Act 1960. And we declare that we do not appoint any Child Labour below the age 14 years for the activities of the Alumni Association.

21. DISSOLUTION CLAUSE: In the event of dissolution or winding up of the Association, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the members of the Managing Committee/Govt. Body but the same shall be transferred to another Association whose objects are similar to those of this Association and which enjoy recognition u/s. 80G of the I T Act. 1961 as amended from time to time.

RULES AND BYE-LAWS

4. MEMBERSHIP: The Membership of the Association shall consist of two categories of members,

7. EXECUTIVE COMMITTEE MEETING: The meetings of the Executive Committee shall consist of two types: (a) Ordinary Meetings; and (b) Special Meetings.

a. **Ordinary Meetings:** The Executive Committee shall compulsorily meet once in three months every year to review the achievements/progress of the previous meeting and stipulate the activities for the coming month.

b. **Special Meeting:** The president of the Executive committee at any time at the request of one-third of the members of the Board of Management or one-tenth of the ordinary members who are eligible to vote convene a meeting in accordance with the provisions of the Karnataka Registration of Societies Act, 1960. 8. QUORUM: The quorum of the general body meeting or special general body, meeting shall have minimum 10 per cent of the members. Any amendments of memorandum of association and rules and bye-laws resolution to be passed shall be assented by two-thirds of such members present in these meetings 2/3 majority of the members present shall effect amendments to its memorandum of association shall effect amendments to its memorandum of association and rules and bye-laws of VVLCAA at any time subject to the provisions of section 9 of Karnataka Societies Registration Act, 1960 subject to the condition that no amendments to the memorandum of association and rules and bye-laws shall be made which may prove to be repugnant to the provisions of Income Tax Act, 1961 and/or contrary to the overall objects of VVLCAA.

9. ELECTIONS: Elections to the Executive committee shall be held once in five years by secret ballot.

10. CONSTITUTION OF THE EXECUTIVE COMMITTEE: The Executive Committee shall consist of 11 members from amongst the members of VVLCAA and it shall consist of one President, one Vice President, one Secretary, one Treasurer and 10 Executive members.

11. POWERS AND DUTIES OF THE EXECUTIVE COMMITTEE: The powers and duties of the Executive committee shall comprise of:

- 13. ANNUAL GENERAL BODY MEETING:** The General Body of VVFGCAA shall hold its meetings and transact business as per provisions of societies Registration Act, 1960. It may transact any other business not inconsistent with the rules and byelaws and VVLCAA.

The Annual General Body (AGM) meeting shall be held every year as per the regulations of the societies Registration Act, 1960. Duly audited annual accounts shall be placed in the annual general body meeting every year. The notice for holding annual general body meeting shall be sent twenty-one days before the date of AGM being held. Agenda circulated along with the meeting of the notice shall include the invitation to send propositions and resolutions, which shall be sent ten days before the date fixed for AGM.

Agenda may include the information relating to calling for nomination in respect of the year when elections are due. In such AGM, elections shall be held by secret ballot. The president of VVLCAA may nominate Returning Officer, who shall take charge of conducting such elections. There shall be a register containing the details of members such as name, address, age, profession etc. There shall also be registers containing details such as meeting proceedings and accounts.

- 14. OPEING OF BANK ACCOUNT AND ITS OPERATION:** The funds of the association shall be deposited in the any scheduled bank as may be decided upon by the executive committee. If the original of the Trust Deed is a registered document, the amendment deed of codicil invariably must be a registered document only.

the High Court for the enforcement of these rights. These Fundamental rights are divided into seven categories which are covered from Article 12 till Article 35 of the Indian Constitution.



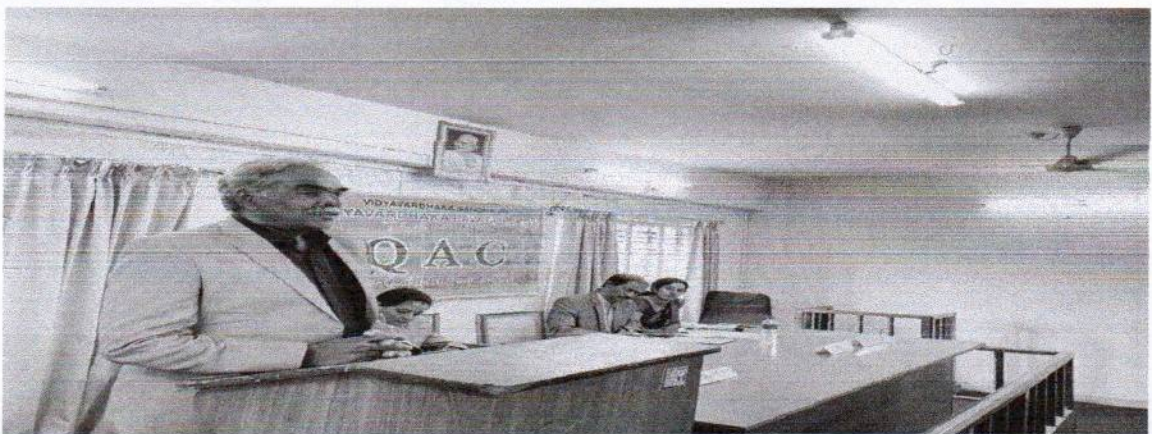
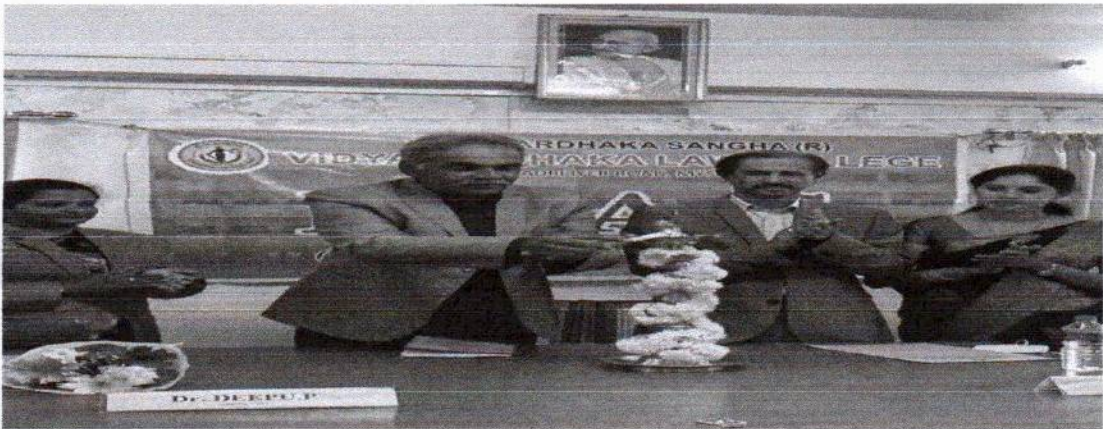

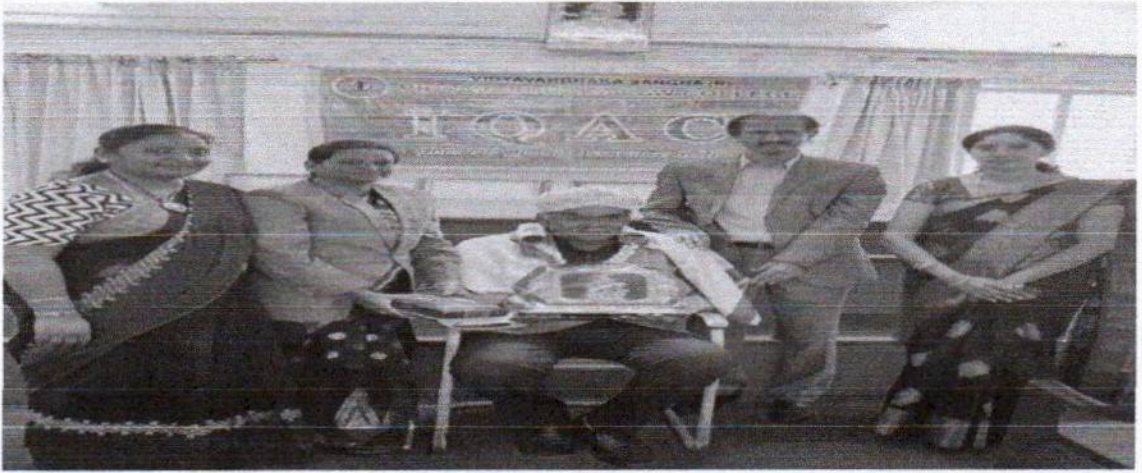
4. On 19th March 2022 at 10.30AM **WORLD CONSUMER RIGHTS DAY** celebrated at

After the inauguration of the programme the chief guest in his inaugural address guest pointed out the various aspects of rights of consumer every year, as a means of raising global awareness about consumer rights and needs. Celebrating the day is a chance to demand that the rights of all consumers are respected and protected, and to protest against market abuses and social injustices which undermine those rights. The actual plight of consumers of India can be declared as completely miserable. He pointed that, out of the various laws that have been enforced to protect the consumer rights in India, the most important is the Consumer Protection Amendment Act, 2019. According to this law, everybody, including individuals, a firm, a Hindu undivided family and a company, have the right to exercise their consumer rights for the purchase of goods and services made by them. On 7th February 2023 at 10.30A M Special Lecture on Enforcement of Directive Principle of State Policy through Judiciary was organised. Dr. N. Satish Gowda Associate Professor University Law College, Bangalore University was the resource person. The resource person explained that, the Constitution is the fundamental law of the nation. An important feature of the constitution is the Directive Principles of State Policy incorporated in the Constitution. Although the Directive Principles are asserted to be "fundamental in the governance of the country," they are not legally enforceable. Instead, they are guidelines for creating a social order characterized by social, economic, and political justice, liberty, equality, and fraternity as enunciated in the constitution's preamble. Judiciary as being the protector and promoter of rights of the individual to perform the balancing act in an unbiased and fair manner has immense role to play in these days to interpret the directive principles as enforceable in order to establish welfare based society. The Directive Principles and state policies therefore offer the state an opportunity for use of the constitution as an instrument for change in definite social directions. The courts can even give directives to the state organs regarding what the state is required to achieve through legislative process.



3. SPECIAL LECTURE

On 23rd February 2023, a special lecture was on 'Law of Taxation' was organized. Sri. M C Sundara, Alumni of Vidyavardhaka Law College, Auditor and Consultant, Mysuru was the resource person. He explained about the Indian Tax Law system and majorly about the Income Tax Law in India.
