

Held on 17th February 2023

The meeting began with the welcome note delivered by Principal Dr. Deepu.P. She introduced Sri K.C Girish, University Nominee to everyone and briefed the agenda of the meeting.

1) Courses offered- Explaining about the courses offered in the college she said, there are two courses B.A, LL.B (5yrs) and LL.B (3yrs). The total intake for B.A, LL.B (5yrs) is 60 and LL.B (3yrs) is 120. The current student strength for B.A, LL.B (5yrs) is 266 and LL.B (3yrs) is 323. Total strength is 589.

Resolution- In this meeting it was resolved that admission process should be carried according to BCI and University norms and resolved accordingly.

2) Faculties' achievement- Principal Dr. Deepu.P explained about faculty achievements. She gave details about faculty members working in the institution. There are 12 full time and 3 part time faculties working in the college. All law faculties are qualified with NET/SLET/Ph.D except two hold doctoral degree. They are also involved in academics, board of examination members, external supervisors and also publications in various national and international reputed journals.

Resolution- In this meeting it was resolved that the management has encouraged faculty members to attend Faculty Development Programme, Orientation Programme and Refresher Courses. Also faculty members should adopt e-learning techniques to expose students to new subjects in law. They should know to write projects and assignments with foot note.

3) 2021-22 Academic events- Principal Dr. Deepu.P explained that every year Orientation Programme will be organized inviting resource persons from various streams like medicine, engineering, spiritual etc. Further she explained about various programmes, special lectures, celebration of national festivals and endowment lecture organized in memory of Late Sri K.Puttaswamy yearly. Events like Mock trial, Inter-class client counselling competition; cultural events etc. are organized yearly

Resolution- In this meeting it was resolved that the college has successfully discharged its functions in organizing various activities in the academic year 2021-22 for encouraging students

4) 2022-23 Academic events- Principal Dr. Deepu.P explained about the programmes organized in 2022-23 ODD semester and also upcoming events. She explained that students had participated in debate competition, elocution, cultural and sports events. They have also participated in inter-class client counselling competition.

Resolution- In this meeting it was resolved that the college has successfully discharged its functions in organizing various activities for encouraging students. It was also resolved that national seminar in association with KSLU will be organized in the next academic semester.

5) Infrastructure- Principal Dr. Deepu.P explained that there are 9 class rooms which are ICT enabled. All the faculties are provided with laptops.

Resolution- It was resolved that management has provided good infrastructure.

6) Examination- Principal Dr. Deepu.P highlighted that all the faculty members are actively involved in examination and evaluation work.

Resolution- It was resolved that all the teachers are involved in examination work and evaluation work of University in systematic way.

7) Internal Test/Practical Papers- it was explained that at the end of the semester IA will be conducted. Test for ADRs, Professional Ethics is also conducted during this time. Viva for practical papers like Professional Ethics and Moot Court is also conducted.

Resolution- It was resolved that IA, examination and evaluation of Practical papers is carried as per BCI and KSLU regulations.

8) Legal Aid- Principal Dr. Deepu.P explained that through Legal Service Clinic free legal aid service is provided to vulnerable class of the society. Legal Aid programme was organized recently at Bendaravade, Deshvalli, Chikkayelachagere as directed by KSLU. Also the college organises NSS and Legal Aid & Legal Literacy Camps annually and Outreach programme periodically.

Resolution- It was resolved that college has been annually organizing Legal aid and Legal Literacy programmes and outreach programmes periodically.

9) Committees- Principal Dr. Deepu.P explained about various committees constituted in the college and respective coordinators of the committees. All the faculty members are organizing events through their committees from time to time.

Resolution- It was resolved that college has constituted various committees/ cell and they have carried out the functions as per KSLU guidelines.

10) Any other issues with the permission of the President/ Secretary- with the permission of the President/ Secretary it was highlighted that college is preparing to go for NAAC accreditation and that IIQA will be filed shortly. For academic year 2023-24 we are going for permanent affiliation.

Resolution- It was resolved that Institution will go for NAAC and the necessary arrangement for the same will be undertaken by the management. Also all necessary preparation for Affiliation, LIC will be undertaken this year.

With the above resolution on the agenda following suggestions were given by the Governing member-

- Orientation Programme should be monitored with its outcome. Orientation
 Programme should concentrate on e-learning, writing project proposals, writing foot
 note in research paper etc. Orientation Programme should be restructured inviting
 best resource persons who can train both students and faculties in this regard.
- 2. Teachers should adopt leaners centric approach and encourage students to learn through books and use e-resources. The programme's outcome should be monitored.
- 3. Test to identify their improvement in learning language should be done. Writing ten legal terms and English words daily and the same in Kannada for a month, students will be able to learn about three hundred words in a month and this will help them to learn language better. They should be given a topic for discussion specifically focussing on current legal developments or new judgment. The college should have a 'Contemporary Legal Development Forum' to discuss about latest judgment and various issues of law. This can be done by teachers as a part of their class room activity too. He also suggested that at least once in a month outdoor activity should be organized for students so that they get a chance to learn law in action.
- 4. Non-law subjects should be given equal importance along with law subjects. They are the foundation for learning law subjects. In this regard even the non-law faculty members should teach the non-law subjects integrated with law subjects. Organizing Faculty Development programme and training programmes in this regard is necessary.
- Learning of law subjects should be based on collaboration with sister institutions.
 Students should know about particle aspects of registering patents which can be best explained by Engineering College faculties.
- Students should be made to analyse case laws and write down the facts, issues involved and the judgment. They should submit assignment on specific case law analysed by them.
- 7. Training for teachers to conduct moot court classes should be given.
- The Governing Council member from University suggested that the Institution should comply with Bar Council of India and KSLU norms.

The meeting concluded with the vote of thanks proposed by Dr. Sridevi Krishna, Asst. Professor and IQAC Coordinator.

The meeting had sufficient quorum. Sri Gundppa gowda, President, VV Sangha ®, Er.P Vishwanath, Secretary, VV Sangha ®, Sri Srishylramannavar, Treasurer, VV Sangha ®, Prof K.B Vasudeva, Director of Legal Studies, VVLC, Dr. Deepu.P, Principal, Sri Girish K.C, University Nominee, Sri Ningegowda H.C were present in this meeting except Sri Swamilingappa, Management Member.

It was decided that institution will go for NAAC and the necessary arrangement for the same will be undertaken by the management.






Object: To understand the concept of gender discrimination, sexual harassment, workplace and basic types of sexual harassment at workplace and how it is related to gender discrimination.

They also suggested the legal provisions relating to Whenever sexual harassment had become so unpleasant and make a worker's life miserable, she would seek redressal under the extant law such as Section 354 (outraging of modesty) or Section 509 (insulting of modesty) of the Indian Penal Code, 1890. She would also seek alternative employment. The employer would on its part, incur significant costs in defending its image and in finding suitable replacements for both the errant and the harassed members of its workforce. Generally, therefore, it had been in the interest of employers that the working environment provides that the workers are treated with dignity.

Many times, performing regular tasks in the workplace can be difficult. By making sure that all the employees go through a necessary PoSH training which can ensure a safe working environment.

- · Trust your instincts about possible danger.
- Discuss it with a close friend or confidant.
- Report sexual harassment to the Human Resource department or respective committee.







Understanding Instances of Sexual Harassment

A number of surveys revealed that a number of unwelcome actions by fellow colleagues are causing harassment among women workers. Prominent of them are:

- a) Derogatory comments of sexual nature or based on gender;
- b) Presence of sexual visual material or pornographic material such as posters, cartoons, drawings, calendars, pinups, pictures, computer programs of sexual nature;
- c) Written material that is sexual in nature, such as notes or e-mail containing sexual comments;
- d) Comments about clothing, personal behavior, or a person's body;
- e) Patting, stroking grabbing or pinching one's body;
- f) Obscene phone calls;
- g) Telling lies or spreading rumors about a person's personal or sex life;
- h) Rape or attempted rape and so on.
