Proposal



Proposal

Proposal

The above Govt. Order No.1 Dt: 28/11/2012 on the basis of Prof Mali Muddanna Report, the 19 law colleges has been subject to grant in -aid, has been agreed and order is passed accordingly. In the above stated Govt. Order SL.No 02 - 05 Dt: 26.08.2015 the eligible teaching and non-teaching staffs are subject to grant-in-aid. But, under the order the teaching faculty appointed after Dt 11.07.2009 without qualifying NET/SLET/Ph.D. were not included under grant-in-aid.

As per Govt. Order SL.No ED 37 UNE 2009, Dt. 24.12.2009, there was a condition that Asst. Professors appointed after Dt. 11.07.2009 should mandatorily possess LL.M degree with minimum 55% and qualify with NET/SLET/Ph.D.

As per the above Govt. Order SL No (6) Dt: 15.11.2017 Department of Collegiate Education out of 19 law colleges had recommended that out of those 48 teaching faculty appointed after 11.07.2009 and not possessing required qualification, 14 Assistant Professors should be admitted to grant-in—aid. In this regard based upon the opinion of finance department out of 14 teaching faculty 08 faculties are subject to grant-in—aid, remaining 06 faculties are dropped out from being subject to grant-in—aid.

As per the Govt. order Dt: 15.11.2017 Smt Indumathi M.J. Asst. Professor, Vidyavardhaka Law College, Mysuru was dropped out from grant-in—aid because of not possessing required qualification.

As per SL No (7) Dt: 22.12.2018 Smt Indumathi MJ, Vidyavardhaka Law College has submitted proposal for including her to grant-in -aid under UGC scale to Commissioner, Department of Collegiate education. Verifying the said proposal order has been passed as below-
