Meeting Proceedings

The Internal Quality Assurance Cell meeting was held on 16th March 2018.

The chairman of IQAC, Prof K B Vasudha, Principal, VVLC formally welcome the members of IQAC. As per the agenda the coordinator of the cell He Sudev; Krishna explained the overall improvements made in the college concerning infrastructure, library, faculty development, college programmes organized, NAAC progress etc.

Following suggestions were given by the members

Dr. Nataraju S, chairman, PG Dept, JSS Law College, Mysuru specified about the date of establishment of IQAC is necessary to be identified and to be mentioned in AAR. The institution should have AIIISH number for processing with NAAC. He mentioned that the objectives of IQAC should be in consonance with the Vision and Mission of the College and the IQAC has to specifically mention the targets achieved and the outcome of it should match all the criteria's of NAAC.

Mentioning about various Committees in the College he gave following suggestion -

1) Alumni Cell should have a record of prominent positions held by the alumnus of the college and it has to call meeting regularly and take their advice and support in overall improvement of the college.

2) He also mentioned about constituting student's cell where 20 students shall support the other students in hearing their grievances and bring it to the notice of the teacher.

3) He mentioned about teacher's Profile, A self appraisal should be prepared by teachers and also an 'Academic Administration Audit' should be conducted where legal experts, academicians etc shall conduct the audit and report about the quality.

3) Mentioning about the collaborations with other institutions, he said that MOU can be made with sister institutions and other organizations like KILPAP, NHRC, Negilayogi, IGNOU etc to organize student extension programmes & other academic activities. All programmes in the college should be done under the banner of IQAC.

4) Students should be encouraged to participate in extensional activities, in NGOs & work in Advocate's office.

5) In Admission, fee charged and fee concession allowed for SC/ST, other backward class students and differently abled students record should be kept ~~-----~~ completed. The annual expenditure to be kept updated specifically differentiating between management budget & college budget. The budget allocation should be separate for all the committees and also certain amount should be reserved for faculty academic progress & support.

4) The number of computers per student ratio was also mentioned.

Dr. Shivalingappa, Principal, SPFGC observed that student support activities should be organised frequently. Observing the results of the College he gave following suggestions -

1) Remedial classes should be conducted for slow learners and every teacher should take initiative in this regard.

2) Students should be provided with language lab so that they can improve their communication skills in English.

3) For teachers, faculty development programmes, workshop should be organised.

4) He also mentioned that Alumni Cell in the college should identify students holding prominent position and also conduct programmes through alumni cell. He also mentioned about keeping record of number of students enrolled in Karnataka State Bar Council as it depicts institute's reputation. There should also be record of number of outgoing students & different positions held by them.

Smt. Deepu P, faculty member of the Cell, said that Faculty Development Programme has been planned to be organized next academic year.



Sri Nagaraju M. Alumni member mentioned that moot court activities should be extended further so that students can learn better about the professional skills and improve their communication.












80% for each faculty member. He also enquired about admission for 5 years B.A., U.B course this year.




































Meeting Proceedings
