As you are aware, the Sexual Harassment of Women at Workplace (Prevention, prohibition and Redressal) Act, 2013 was notified on 9th December, 2013 to provide a safe and secure environment to women at the workplace.

Sexual Harassment results in violation of the fundamental rights of a woman to equality under articles 14 and 15 of the Constitution of India and her right to life and to live with dignity under article 21 of the Constitution and right to practice any profession or to carry on any occupation, trade or business with includes a right to a safe environment free from sexual harassment.

The protection against sexual harassment and the right to work with dignity are universally recognized human rights by international conventions and instruments such as Convention on the Elimination of all Forms of Discrimination against Women, which has been ratified on the 25th June, 1993 by the Government of India.

University Grants Commission has also notified University Grants Commission (Prevention, Prohibition and redressal of sexual harassment of women employees and students in higher educational institutions) Regulations, 2015 in the Gazette of India which are available on UGC website i.e [www.ugc.ac.in](http://www.ugc.ac.in). These Regulations clearly describes responsibilities of the higher educational institutions, grievance redressal mechanism, process for making complaint and conducting inquiry interim redressal, punishment and compensation, consequences of non-compliance etc. UGC Regulations being statutory in nature are binding for universities and colleges.

The Ministry of Education has requested to take the following action in order to sensitize the issue related to maintenance of safe working environment as per "Sexual Harassment of Women at workplace (Prevention, Prohibition and Redressal) Act, 2013"

- i. To issue advisory to the Universities /Colleges/Higher Educational Institutions (HEIs) to constitute an Internal Complaints Committee (ICC) and a Special cell in the institutions under your administrative control to deal with the issue of gender based violence and to conduct gender sensitization programmes.



- iv. To upload the (i) "Sexual Harassment of Women at Workplace (Prevention Prohibition and Redressal) Act, 2013":- (ii) Constitution of the Committee and details of the Members of the Complaints Committee such as name, phone number, address etc. on their respective portals.
- v. To conduct training programmes to sensitize the employees of the Institutions.

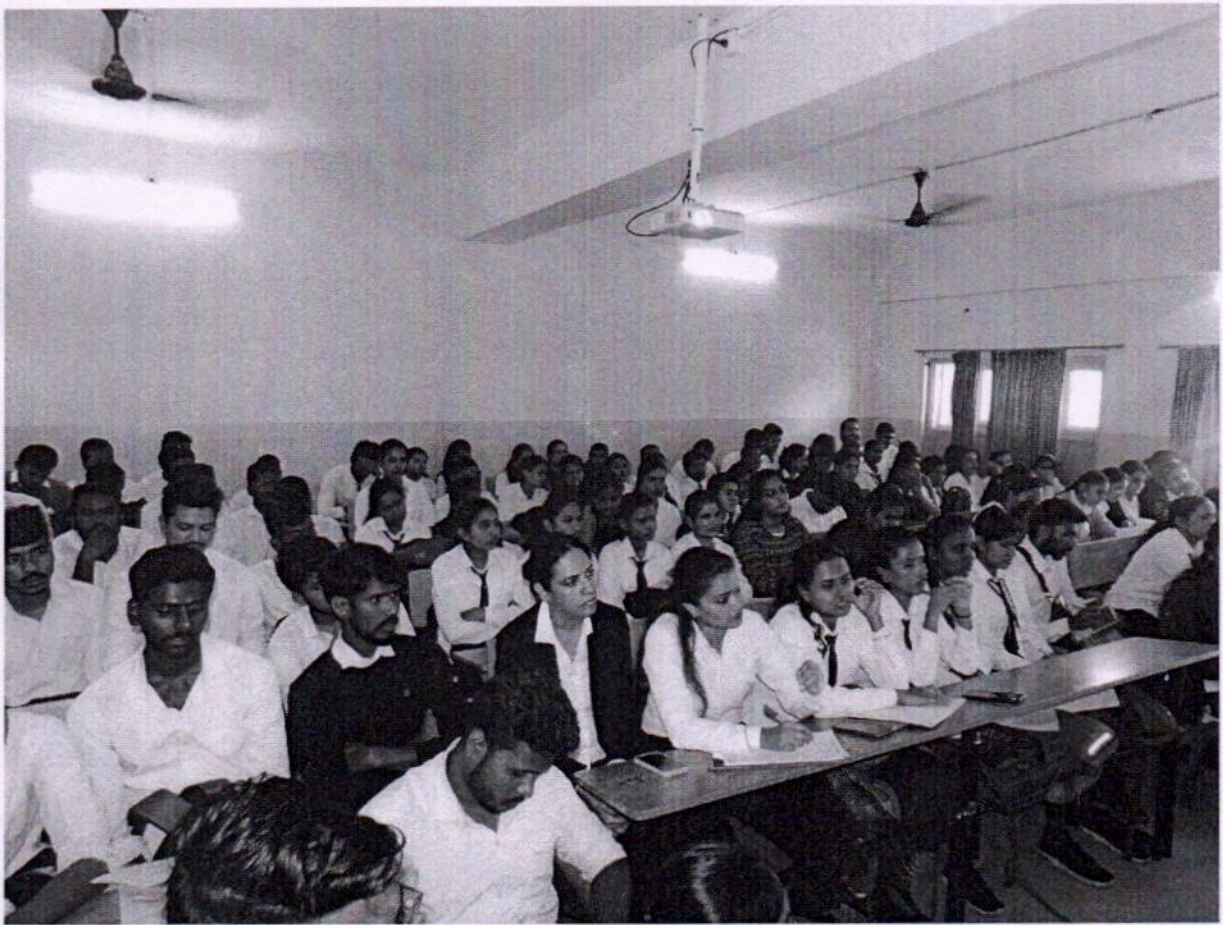

Generally, therefore, it had been in the interest of employers that the working environment provides that the workers are treated with dignity.




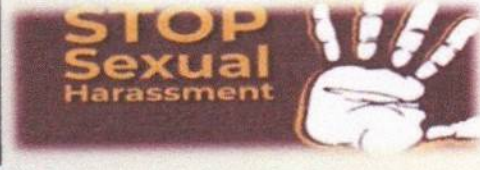

The Prevention of Sexual Harassment (PoSH) at Workplace Act of India mandates every organization to define their sexual harassment policies, prevention systems, procedures and service rules for its employees. Recent reports claim a rise in the number of cases registered for sexual harassments at the workplaces. Also, the number of women in the corporate world reporting such severe incidents are increasing. Such incidents at the workplace can be strenuous to the employees as well as to the entire organization.

Actions like these result in undesirable physical and emotional ramifications. It adversely affects the productivity of employees creating an unpleasant atmosphere. Many times, performing regular tasks in the workplace can be difficult. By making sure that all the employees go through a necessary PoSH training which can ensure a safe working environment.



He also explained what is sexual harassment? She said that, Any form of discrimination that includes unwelcome attention of sexual nature is considered sexual harassment. It involves a range of behaviours from seemingly mild transgressions and annoyances, to actual sexual abuse or sexual assault. Anyone

from either gender can be a victim of sexual harassment, and anybody from either gender can be a perpetrator. Sexual harassment also includes the conduct of co-workers who engage in verbal or physically harassing behaviour which has the potential to humiliate or embarrass an employee or the company.



She also explained the, **STEPS YOU MUST TAKE FOR POSH**

- Dealing upfront with the harasser.
- Do not pretend it did not happen.
- Immediately inform the alleged harasser that the behaviour is unwelcome.
- Demand that the harassment must stop.
- Reinforce your statements with a firm tone and professional body language.
- Trust your instincts about possible danger.
- Discuss it with a close friend or confidant.
- Report sexual harassment to the Human Resource department or respective committee.

### **Understanding Instances of Sexual Harassment**

A number of surveys revealed that a number of unwelcome actions by fellow colleagues are causing harassment among women workers. Prominent of them are:

- a) Derogatory comments of sexual nature or based on gender;
- b) Presence of sexual visual material or pornographic material such as posters, cartoons, drawings, calendars, pinups, pictures, computer programs of sexual nature;
- c) Written material that is sexual in nature, such as notes or e-mail containing sexual comments;
- d) Comments about clothing, personal behavior, or a person's body;
- e) Patting, stroking grabbing or pinching one's body;
- f) Obscene phone calls;
- g) Telling lies or spreading rumors about a person's personal or sex life;
- h) Rape or attempted rape and so on.
