The Question and Answer Session

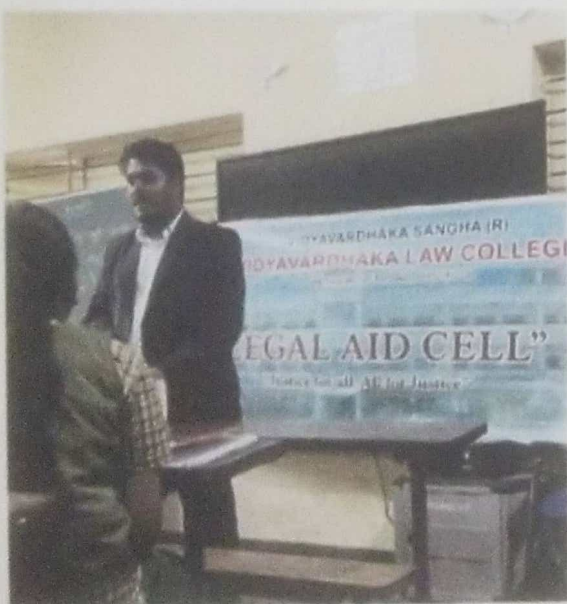

The Conclusion of the Program

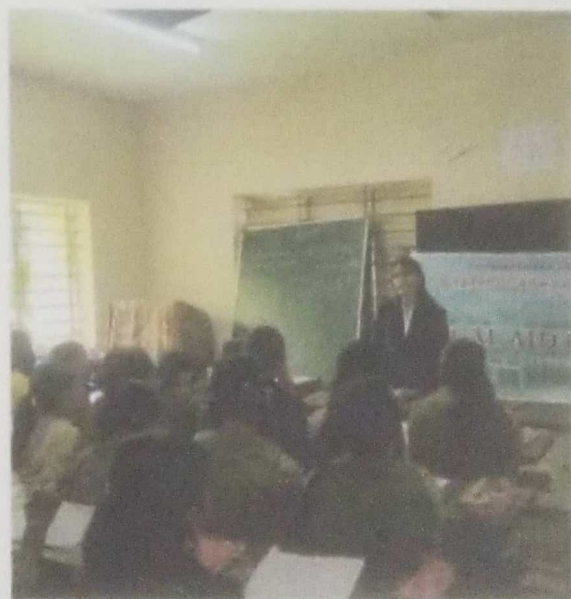

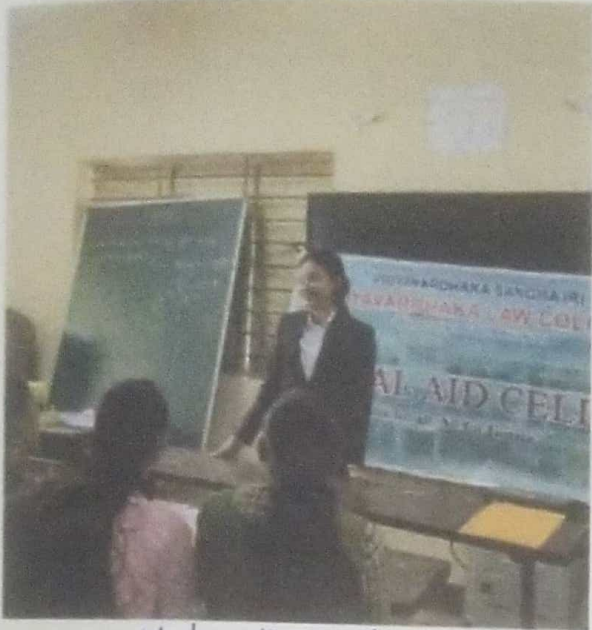
