The Welcome Address

The program commenced at 3 pm with a warm welcome by Mrs. Poornima, the Principal of Rotary West School. She introduced the guest speakers and emphasized the importance of legal awareness and safety for students.

1. Drugs and Tobacco Abuse

Mr.Anil kumar and Ms..Anitha S, a final-year law student, addressed the gathering on the severe impacts of drugs, tobacco, and nicotine. He highlighted the detrimental effects these substances have on general health and fertility Mr.Anil kumar A strongly advised students to stay away from such harmful habits and provided insights into the long-term consequences of substance abuse.

2. Child marriage.

Ms.Divya K And anjali spoken about the, child marriage is when boys or girls who are still children—usually under the age of 18—are married off to older partners. This practice can prevent children from finishing their education, and it often leads to serious health risks and limits their future

opportunities. It's considered harmful because it takes away their childhood and can have long-lasting negative effects on their lives."

3. Fundamental rights and duties

Ms.Amrutha and Divya shreedar spoken about the "Fundamental rights are essential freedoms guaranteed by the constitution to every citizen, like the right to equality, freedom of speech, and education. Duties are responsibilities that citizens must fulfill, such as obeying laws, paying taxes, and respecting others' rights. Together, they form the cornerstone of citizenship, ensuring rights are upheld while promoting a sense of responsibility towards society."

4.POSCO

Mr.anoop and Athish kiran bhatte The Protection of Children from Sexual Offences (POCSO) Act, 2012, is an Indian law aimed at safeguarding children against sexual abuse and exploitation. It provides a robust legal framework for the protection of minors, with stringent punishments for offenders. The Act mandates special courts for speedy trials and ensures child-friendly procedures during the legal process. POCSO includes provisions for mandatory reporting of offenses, with penalties for failure to do so. Additionally, it emphasizes the importance of safeguarding the identity and dignity of the child victim throughout the legal proceedings.
