The IQAC and NSS Unit has organised **"World Day of Social Justice-2024"** programme with the theme-**Bridging Gaps, Building Alliances-Overcoming Barriers & Unleashing Opportunities for Social Justice**, on 24-02-2024 at Lecture Hall No 2 of VVLC. Dr. Deepu. P., Principal welcomed resource person Prof. Shivananda Bharathi and Prof K.B. Vasudeva, Director of Legal Studies has introduced the resource person to the students.





The resource person Prof. Shivananda Bharathi, while addressing the students has explained the importance of World Day of Social Justice-2024. They informed that the concept of social justice embedded in various international legal instruments as well as national legal instruments. There are international as well as national level machineries with the responsibilities to enforce the social justice. Still there is social injustice in rural areas on various aspects across the globe. This is against to right of equality. Trade unions came into existence through the freedom of association with the collective bargaining.

Object of social justice right to dignified life and it requires the equal wages. Hence minimum wages act and payment of bonus act came into operation. To secure the dignified life, right against exploitation conferred in various aspects. Most of the judges are the judges of the court of law and not the judges of the social justice. After the constitution came into force and provisions of directive principles of state policies are the major instruments to the state to uplift the downtrodden sections and vulnerable sections and to establish the social welfare state. Factories Act and Industrial disputes Acts are other legal instruments for establishment of good working environment. Some other legislatives are enacted for the social justice of unorganized working groups in country and state has to take further affirmative action to ensure social justice to the need sections of the nation.
