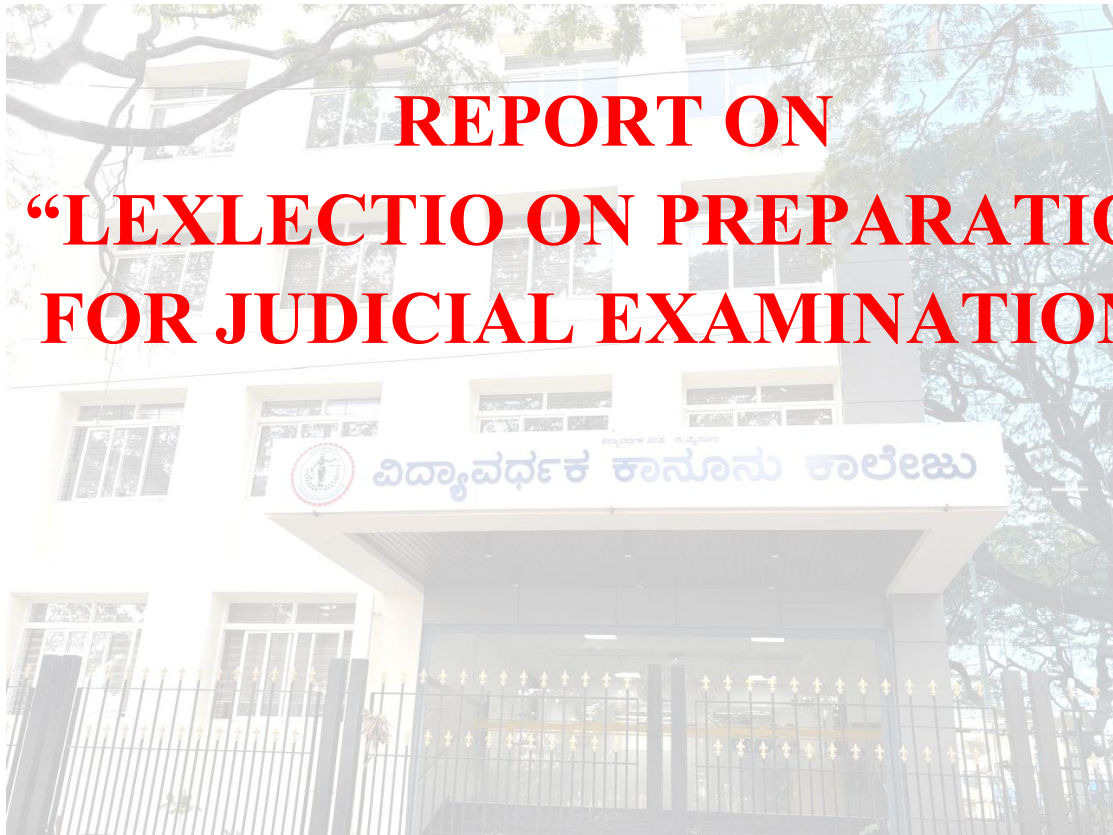

REPORT ON CAREER GUIDANCE PROGRAMME

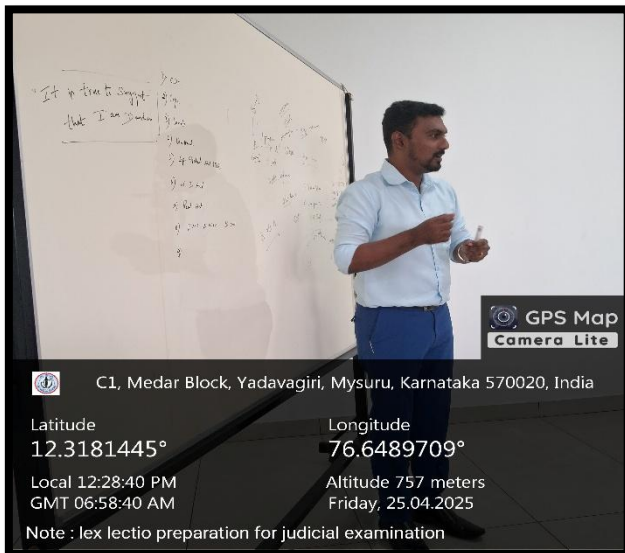
On 25th April 2025 Lex Lectio on Judicial Examination Preparation was organized at Moot Court hall for both 5 years B.A, LL. B programme and 3 years LL. B Programme. Sri Harsha, Judicial Magistrate, Kolar who is also an alumni of our college addressed the students. Dr. Sridevi Krishna welcomed the guest and the programme was presided over by Sri Shivakumara H.S, Asst.Professor, VVLC. Addressing the students he firstly enquired the students on their interest in preparing for judicial examination. He explained them about various stages in preparation of judicial examination which comprises like preliminary, main exam and viva voice. The subjects covered are usually the procedural laws with latest updates. He also mentioned that translation paper requires special concern during preparation as it requires in depth knowledge of both Kannada and English. Deeds, pleadings etc are asked for translation and hence one needs to be thorough with the formats of these documents. Preliminary examination carries 60 marks and securing minimum marks is sufficient whereas, in mains which comprises two papers including translation preparation for the same is essential as those who get through this will be called for viva.

Further he also mentioned that at least minimum 3 years of practice in bar is required for one to understand the court procedures and analyses the case. He said that students can chose either to practice civil side or criminal side. But this requires more clarity during viva as they ask questions from the area of practice of the aspirant.

Further he posed few illustrative questions for students which was answered and analysed with mutual interaction.

The programme concluded with vote of thanks delivered by Dr. Sridevi Krishna.
