



Civil cases are assigned to panel of advocates; hence legal profession has wide opportunity. Opportunity is available in this profession and that required dedication.

In today's competitive world legal profession has reached its peak and is in huge demand, he added. He also advised the new batch that learning English is very important in your profession since judgements of superior courts are available in English. What many fail to realize is this "modern lifestyle" has become increasingly unsustainable. The number of people with one or more chronic conditions has grown by over 40 million people in the U.S. in the past 25 years. The majority of this impact is a result of lifestyle factors like high stress, lack of sleep, and poor nutrition, among others.


If current trends continue, this number is expected to reach over 170 million in the next decade — despite the billions of dollars invested in healthcare every year. What is needed now more than ever is a reevaluation of how our behaviors affect our health, and the incorporation of this concept into healthcare, so that we can make appropriate long-term changes to our lifestyle.

Acknowledging mental health as a principally impactful driver of individual and national development, the Survey notes that as per the National Mental Health Survey (NMHS) 2015-16, 10.6% adults in India suffered from mental disorders while treatment gap for mental disorders ranged between 70% and 92% for different disorders. Further, the prevalence of mental morbidity was higher in urban metro regions (13.5%) as compared to rural areas (6.9%) and urban non-metro areas (4.3%). Citing NCERT's Mental Health and Well-being of School Students Survey, the Survey highlights an increasing prevalence of poor mental health among adolescents exacerbated by the COVID-19 pandemic, with 11% of students reported as feeling anxious, 14% as feeling extreme emotion and 43% experiencing mood swings.

Mental health disorders are associated with significant productivity losses due to absenteeism, decreased productivity, disability, increased healthcare costs, etc. There is also evidence of poverty affecting the risk of mental health via stressful living conditions, financial instability, and a lack of opportunities for upward mobility, which contribute to heightened psychological distress.

So,People should regularly exercise or do the yoga practice, eat well,get enough sleep, stay connected, and be active always. So that one can have good mental and physical health.

Topic -Art of Advocacy

Advocates are also known as the officers of the court who play an important role in the administration of justice for the people. The code of conduct for advocates defines the rules of advocates conduct and principles of advocating ethics.

The rules that govern the professional conduct comes out from the duties that they owe to the court, the client, their opponents and other advocates. Our society depends upon the rule of law, advocate performs a special role. Advocate is called to serve both the interest of justice and those rights and privileges that are entrusted to him/her to defend the rights of his/her client.

Topic -Law and Language





Prof Rajgopal Rtd. Prof of English Regional institute of education Mysuru topic; he spoke about the Use of language in Law The use of language is crucial to any legal system, not only in the same way that it is crucial to politics in general, but also in two special respects. Lawmakers characteristically use language to make law, and law must provide for the authoritative resolution of disputes over the effects of that use of language. Political philosophers are not generally preoccupied with questions in the philosophy of language. But legal philosophers are political philosophers with a specialization that gives language (and philosophy of language) a special importance.

Philosophy of law can gain from a good philosophical account of the meaning and use of language, and from a good philosophical account of the institutionalized resolution of disputes over language. Philosophy of language can gain from studying the stress-testing of language in legal regulation and dispute resolution. And philosophers of language can gain from the reminder that their task is not only to account for what people share in virtue of the mastery of a language; they also need to account for the

possibility of disagreements over the meaning and use of language, and for the possibility that there might be good reason for resolving those disagreements in one way rather than another.

#### Personality

- Every individual has his own characteristic way of behaving, responding to emotions, perceiving things and looking at the world.
- No two individuals are similar.
- ▶ Personality also influences what we think, our beliefs, values and expectations. What we think about others depends on our personality.
- ▶ In a layman's language personality is defined as the personal qualities and characteristics of an individual. Personality is how we interact with others.
- ▶ Personality is a sum of characteristics of an individual which makes him different from the others. It is our personality which makes us unique and helps us stand apart from the crowd.
- ▶ Personality is a multi-dimensional and intricate concept that describes the unique patterns of thinking, feeling, and behaving that differentiate one person from another

#### **Legal Personality**

▶ What does legal mean- The term "legal" means something is acceptable or allowed by law. The legal things are fully authorized by jurisprudence (philosophy of law). --- The terms: legal

access, legal advice, legal affairs, legal assets, legal heirs, and legal migration are common adjectives.

- ▶ What does illegal mean--The term "Illegal" is the opposite, and it means "not legal" that is prohibited by law. The official law and rules consider criminal activities strictly forbidden. Illegal things are unauthorized by jurisprudence (philosophy of law). In short, illegal means against the law.
- Legal consciousness of an individual and a group consists of the following three basic elements:
  - legal knowledge;
  - ► social legal attitudes; and
  - behavioural habits.
- Three basic elements may be distinguished in the structure of individual legal consciousness.

  These are:
  - legal knowledge;
  - emotions and attitudes; and
  - readiness for lawful behavior (actual behavior).
