Now a day's laws are also evolving on artificial intelligence and as per the legal scholars intellectual properties are recognised as nation's new properties. Now a day's majority of the people uses mobile as device which has artificial intelligence but this generation has been losing their sense of words and knowledge and they believing what they see and hear through such devises. Due to development of science and technology cybercrimes are also rampantly been increasing in all the society.
