(a) Mr. 'Pinto' was a clerk at Indian Embassy in England. He was dismissed from service on the charge of stealing documents. On the same day, the Indian Ambassador waived his immunities in this respect. Mr. Pinto was arrested and tried. He claimed that being a servant of diplomatic envoy he was immuned from the court proceedings. Whether he succeed in this case? Give reason.
